

DC Healthy Families Insurance (SCHIP)

What is DC Healthy Families Insurance?

DC Healthy Families is a Medicaid program for the children of parents whose incomes are too high for Medicaid, but still too low to pay for their children's health insurance. SCHIP covers doctor's visits, vision, dental care, prescription medication, hospitalization and more. Those who may be eligible include:

- Children
- Adolescents under the age of 19 who live alone
- Parents and guardians of children
- Pregnant women

How does it work?

Medical services are provided through a system of doctors located throughout the District of Columbia. DC Healthy Families coverage is quite complete and includes well and sick doctor visits, immunizations, vision, dental and other health services.

How does one apply?

- Complete a [DC Healthy Families Application for Health Insurance](#). *Childless adults who are not pregnant, elderly and disabled individuals, and Medicare participants should complete and submit a [Combined Application for Benefits form](#), instead.*
 - Visit a local DHS Income Maintenance Administration Service Center.
 - Call a local DHS Income Maintenance Administration Service Center and ask that an application be mailed to you.
 - Pick up an application at your local library, Giant, Safeway, CVS, or Rite Aid.
